Special Participation Agreement
Summer Camp 2020

Waterville Valley Recreation Department welcomes you to camp this summer. Due to the ongoing health pandemic WVRD has instated new rules and procedures for this summer, consistent with Governor Sununu's COVID-19 Reopening Guidance to reduce the risk of infection.

To promote safety during our 2020 summer camp, all campers/families must follow the following procedures and rules. **Failure to comply with these safety precautions may result in either temporary or permanent withdrawal from the 2020 WVRD summer camp.**

I understand and agree to the following:

Day camp attendees are restricted to children who are New Hampshire residents or out of state campers who have met a 14-day quarantine requirement. By signing below, I confirm that my camper meets those criteria.

My camper will be screened daily by WVRD Health Counselor before being checked in and admitted to camp. Screening will include checking for fever or other symptoms of COVID -19 and confirming there are no travel risk factors.

Participants that arrive to camp with a fever a cough or other symptoms of COVID -19 or report exposure to anyone with COVID-19 or have traveled outside the state of NH in the past two weeks will not be permitted to participate. Parents must wait until screening and be available to bring their child home if necessary.

Waterville Valley Recreation Department will have a Health Counselor available if anyone develops symptoms of COVID -19 or any other health related problem during the day. Anyone with suspected or confirmed COVID 19 will be removed from participation until they can be picked up and must stay out of day camp until at least 10 days have passed since symptoms first appeared AND at least 3 days (72) hours have passed since recovery which is defined as resolution of fever without medication and improvement of all other symptoms.

I agree I will not send my child to camp if they have a fever or cough or exhibit other symptoms of illness and will be available or will designate an available adult who can pick up my camper if she/he becomes ill during the day.

Daily drop off will be done through using FAMILY. I agree to download and use this app for check in and pick up and to minimize direct contact as much as possible.

Parents will not be permitted inside the building and will be required to wear a mask outside vehicles.

Campers will not be required to wear masks but will be reminded to practice social distancing.

Campers will be encouraged to wash their hands frequently but at a minimum upon arrival, after outdoor activities, before and after snack and lunch and after sneezing or coughing. Hand sanitizers will be available as well. I agree to allow my child to use alcohol- based hand sanitizer if soap and water are not readily available during an activity. If I do not agree to use of alcohol-based sanitizer, I send my child to camp with my choice of hand-sanitizer for their individual use.

Staff will not be applying sunscreen or insect repellent to campers. All campers should arrive at camp with sunscreen and repellent applied and should be instructed on how to reapply after swimming or as needed. Staff will oversee application only.

Non-essential visitors will not be permitted at camp. As such, if a parent will not be coming to pick up an authorized person must be designated for daily pick-up. Pick up is at 3 pm and late arrival may be subject to a \$5 fee which will accrue for each 10 minutes after 3.

Sports equipment will be provided by WVRD and will be cleaned regularly. Campers may not bring their own equipment to camp.

In addition to snack and a packed lunch, campers must bring their own water bottle each day. It gets hot and when we are outside campers run the risk of dehydration if they do not drink water regularly. Campers may not share food, water bottles or utensils.

Please refer to WVRD's COVID Preparedness Procedures for a full list of precautions and parent expectations.
